## Online Class Enrollment – Fall Term 2025-26

Class enrollment of postgraduate students will begin on 26 August 2025 at 6:00pm. Through the Student Information System (SIS), students can submit their class choices and confirm class places online with the University's network account. Before class enrollment starts, students may validate their eligibility to enroll a class via the same system on 22 August 2025 onwards.

Students should activate their ITSO (Information Technology Services Office) network account for access to the University network services. Please refer to the ITSO website at <u>https://itso.hkust.edu.hk/info/student</u> for information.

After completing program registration with the University, a student with valid HKUST network account may access the class enrollment functions of SIS the **next day**.

## **Online Class Enrollment of New Postgraduate Students**

Fall Term 2025-26

The Student Information System facilitates the administrative processes of class enrollment of postgraduate students. Students should refer to the Program / Course Catalog & Academic Regulations 2025-26 for information about program requirements. Please approach your program office and / or supervisor, and consult them for academic advice on class enrollment. You should submit your class requests according to their advice.

New postgraduate students who have formally registered in their program will start class enrollment <u>at 6:00pm on 26 August 2025</u> (Tuesday). Enrollment is open from 26 August onwards for new students who have completed program registration. The following summarizes the important enrollment dates:

22 Aug 25 (9:30am) onwards	Class Validation (Note 2)	
26 Aug 25 (6:00pm) onwards	Class Enrollment (Note 2)	
1 Sep 25	Commencement of Fall Term 2025-26	
1 - 13 Sep 25	Add/Drop Period (Note 3)	
15 - 27 Sep 25	Extended Drop Period (Note 3) – for postgraduate courses only	

Important Notes:

- 1. Registered students can access Student Information System via the Student Intranet at <u>https://hkust.edu.hk/stu\_intranet/</u>. The ARO webpage is at <u>https://registry.hkust.edu.hk</u>.
- 2. The system is open for enrollment every day except during the system maintenance period of 7:30am-9:30am every morning.
- 3. Some classes do not follow the regular add/drop and extended drop periods as announced above. Please refer to the 'Class Search' functions to look up the class information or ARO webpage for the exceptions.
- 4. Study load requirements/restrictions

**Taught postgraduate programs** - The normal study load for full-time students is 12 credits per term, with 9 credits being the minimum. The maximum study load of part-time students is 8 credits per term, including normal credit load of audit courses. The MBA and the MSc programs offered by the School of Business and Management have a heavier study load than other taught postgraduate programs.

**Research postgraduate programs** - The normal study load of full-time students is 10 credits per term whereas the maximum study load for those in part-time mode is 8 credits per term, including normal credit load of audit courses.

- 5. Students who **start** their thesis research/project courses in Fall term 2025-26 must submit class enrollment requests to add the thesis/project courses formally.
- 6. Research students who are interested in taking courses under the <u>PG course sharing scheme</u> among local universities or under the <u>HKU-CUHK-HKUST Joint Centre for Advanced Study</u> may look up the information on the ARO webpage.
